# **CUSTOMS MANAGEMENT ACT, 2011**

## **(No. 30 of 2011)**

### **CUSTOMS MANAGEMENT (AMENDMENT) REGULATIONS, 2023**

The Minister, in exercise of the powers conferred by section 354 of the Customs Management Act, 2011, makes the following Regulations —

**1. Citation and commencement.**

- (1) These Regulations, which amend the Customs Management Regulations (*S.I. No. 62 of 2013*), may be cited as the Customs Management (Amendment) Regulations, 2023.
- (2) These Regulations shall come into force on the 1<sup>st</sup> day of July, 2023.

**2. Amendment of regulation 2 of the principal Regulations.**

Regulation 2 of the principal Regulations is amended by the insertion of the following definition in the appropriate alphabetical position —

“**concession**” means any allowance for the exemption or reduction of import duty as specified in —

- (i) Chapter 98 of the Special Classification Provisions in Part D of the Schedule to the Tariff Act; and
- (ii) Chapter 98 of the Special Classification Provisions in the Second Schedule to the Excise Act;”.

**3. Amendment of regulation 9 of the principal Regulations.**

Regulation 9 of the principal Regulations is amended by the insertion, immediately after paragraph (2), of the following as a new paragraph (2A) —

“(2A) Notwithstanding paragraph (2), where a master of a vessel has not reported the arrival of the vessel, the master commits an offence and is liable on conviction to a fine not exceeding one hundred thousand dollars.”.

**4. Amendment of regulation 10 of the principal Regulations.**

Regulation 10 of the principal Regulations is amended —

- (a) in paragraph (1), by the insertion, immediately after the word “C7”, of the words “and C7B”;
- (b) in paragraph (3), by the insertion, immediately after the word “C7”, of the words “and C7B”.

**5. Amendment of regulation 93 of the principal Regulations.**

Regulation 93 of the principal Regulations is amended by the insertion, immediately after paragraph (2), of the following as a new paragraph (3) —

- “(3) A person who fails to apply for an extension of a cruising permit for a vessel under paragraph (1) commits an offence and is liable on conviction to a fine not exceeding one hundred thousand dollars or confiscation of the vessel.”.

**6. Amendment of regulation 147 of the principal Regulations.**

Regulation 147 of the principal Regulations is amended by the insertion, immediately after paragraph (5), of the following as new paragraphs (5A) and (5B) —

“(5A) A processing fee of twenty-five dollars shall be payable on all concession declarations.

(5B) Notwithstanding paragraph (5A), a processing fee shall not be payable on the following concession declarations on goods and equipment imported —

- (i) by consular or diplomatic persons;
- (ii) by international organizations;
- (iii) by charitable organizations;
- (iv) by religious organizations;
- (v) for the handicapped, chronically ill, socially disadvantaged and elderly persons; and
- (vi) pursuant to exigency orders.”.

**7. Revocation and replacement of regulation 149 of the principal Regulations.**

Regulation 149 of the principal Regulations is revoked and replaced by the following as a new regulation 149 —

**“149. Environmental levy.**

- (1) In accordance with section 354 of the Act, an environmental levy is payable on the import of the goods specified in the second column of the Second Schedule at the rates specified in the third column of the Second Schedule.
- (2) The Minister may waive an environmental levy on goods imported under TARIFF CODE Headings/Subheadings 87.01, 87.02, 87.03, 87.04 and 87.05 of the First Schedule to the Excise Act.”.

**8. Revocation and replacement of Second Schedule to the principal Regulations.**

The Second Schedule to the principal Regulations is revoked and replaced by the following —
